

Terms and Conditions



Lewes Santa Run 2018

From Harvey's Brewery, Lewes

The Bevern Trust Lewes Santa Run (Event) is organised and operated by The Bevern Trust (Run Organiser) Registered Charity no. 1103520.

1. By booking and paying for Santa Run places, I declare that I will abide by the rules of the Event and that I shall be, at the date of the event, fit and able to complete the Event and that the details given in the form are correct in all particulars.
2. I agree to abide by these terms and conditions of entry and any run instruction given to me by the Run Organisers or officials during the Event.
3. The Run Organisers are only able to accept limited entries in advance.
4. The entry fee is non-refundable.

Entry rules for participants

5. Under 16s

- must have written permission from a parent or guardian
- must give contact details for a parent or guardian

6. 16 and Over

- can enter individually

7. Only registered participants are eligible to take part in the Event.

8. All participants under the age of 16 years of age on 1st December 2018 must be accompanied by a participating responsible adult.

Equipment and communications

9. All registered persons over 5 years of age will receive a standard one-size Santa suit. All registered persons 4 years and under will receive a Santa hat.

10. All participants are responsible for ensuring that where necessary their Santa suits are adjusted to fit and that the participant will be able to run safely whilst wearing the Santa suit.

11. By agreeing to these terms and conditions you will receive a limited number of Run Organisers emails, which will include Event information and the latest updates

on the Event itself.

12. All participants must carry their name, details of any health problems or medication and emergency contact name and number on them during the event.

13. In the case of an emergency the Run Organiser may use the details provided by you to contact your home or office or emergency contact.

14. The Run Organiser complies with the Data Protection Act 1988. We will use your personal information to administer the Event and to send you details of further events from The Bevern Trust.

Cancellation

15. If the Event is cancelled or delayed due to unforeseen circumstances, we will endeavour to stage the Event at a later date. In such circumstances, we will try to let you know in writing of the cancellation or delay. Our entire liability in respect of all costs and expenses you may incur because of such cancellation or delay will be the entry price you have paid to take part in the Event.

16. I agree that should the Event be cancelled due to an event beyond the reasonable control of the Run Organisers including but not limited to: severe weather, terrorism, act of god, closure of the area by emergency services, medical advice or pandemic I will not be entitled to a refund of the entry fee.

Training and Medical conditions

17. It is strongly recommended that you train and prepare for the run. If you have not exercised before or for some time, or have a pre-existing medical condition, you should consult your doctor prior to the Event.

18. I understand that I am taking part in a fun run which may require me to undertake varying levels of exercise, including vigorous, for a prolonged period. I will have, if necessary, gained advice from my GP as to whether I am physically prepared to undertake the Event. I agree that I will take appropriate action to prepare myself for this Event. I also understand that I will only undertake the event if I feel that I am physically able to do so.

Ejection

19. The Run Organisers reserve the right to refuse an entrant attendance at, and/or participation in, the Event or any future Event. Any participant who is found in breach of these terms and conditions will be excluded from any future events organised by the Run Organisers.

Sponsorship money

20. You have a legal responsibility to ensure that all sponsorship monies/donations received by you for the Event are paid to The Bevern Trust, Registered Charity No 1103520, Bevern View, The Willows, Barcombe, Lewes BN8 5FJ.

21. Participants can hand their sponsor money direct to The Bevern Trust at the address above or hand your collected sponsor money to our charity officials at registration on the morning of the Event.

Images

22. By taking part in the Event, you give permission for the free use of your name, voice, footage or any photograph to be used in any broadcast, advertising, promotion, or in any future communications of The Bevern Trust.

23. By registering an under 16yr old as a participant, the parent or guardian confirms that they are happy for any footage or photographs taken which may feature the under 16yr old during their participation in the Event to be used in this way.

Risk and liability

24. All participants enter this Event entirely at their own risk and the Run Organisers shall not be liable for any injury or loss that might occur because of their participation other than because of the Run Organisers.

25. The Run Organisers take all reasonable steps to minimise the risk of injury to participants during the Event, including undertaking a detailed risk assessment which aims to minimise or eliminate the risk to everyone taking part. However, by taking part in this Event, you acknowledge that there may be conditions or circumstances beyond our control that can lead to unforeseen risks.

26. By entering the Event, I accept all the conditions of entry and acknowledge that, to the extent permitted by law, the organisers and sponsors shall have no liability to me and team members for any injury, loss or damage, nor any consequential loss or damage suffered by me at or by reason of the Event.

27. Any dogs brought to the Event must be kept on a lead at all times.
